RECIPE CORNER



Stay cool this summer with \dots

Frozen Lemon Pops

½ cup plus 1½ cups water (2 cups total)
½ cup honey
½ cup lemon juice
Thinly sliced lemon
Add chopped basil for a twist

Make a simple syrup by heating ½ cup water in a small saucepan until Remove from heat and stir in the honey. Once the honey is dissolved, stir in ½ cup lemon juice and the remaining 1 ½ cups water. Pour the mixture into the frozen pop molds. If desired, put thin slices of lemons and basil into the molds for added flair and punch of flavor. Freeze. If using sticks, after 2 hours, remove from the freezer and insert the sticks and freeze for an additional 3 hours. If handles are a part of your molds or your mold cover has a slit for the stick, then skip this step. Once completely frozen, remove from freezer and remove the frozen pops from the molds. Store them between pieces of wax paper in an airtight container in the freezer. (Be sure to unmold your frozen pops – if you wait days or weeks, they will be much harder to get out.)
